Important Information & Rules

Jurying

Please provide four (4) photographs of your work and one (1) of your booth. Acceptance is at the discretion of the jury and priority is given to applicants whose work meets the jury's standards. Do not send samples of your work.

Application Deadline

Applications, photographs and fees **must be received 30 days** prior to event. Applications must include a stamped, self addressed envelope of sufficient size and postage for returning photos. Otherwise photos will not be returned. Photos sent by accepted vendors will **not** be returned. First come first served - Spaces are assigned in the order received.

Fees

Booth fees are due and payable with application and payable by check or money order only. **Please make checks payable to: DVVID.** Events are held rain or shine. No refunds will be given. If you are not accepted your check will be returned to you.

Important Requirements

Vendors assume responsibility for paying sales tax and comply with applicable federal, state and local statues and ordinances.

California Seller's Permit

Vendors must have a valid California Seller's Permit. Permits are available through the State Board of Equalization in your area and **a copy must be submitted with application.**

Liability Insurance

Vendors must provide documentation of general liability insurance in the amount of \$1 million. You must provide a Certificate of Liability naming the City of Vacaville and the Downtown Vacaville Business Improvement District as additionally insured in the amount of one million dollars.

Maps indicating vendor parking will be provided upon acceptance.

Booths and displays

Booth spaces are outdoors

Booth Fees are based on the following dimensions:

10 x 10 Single Space

Spaces are assigned on a first come basis

Vendors provide their own displays, tables, chairs, shelves, shade covering, etc., within the assigned booth spaces.

Displays must be orderly and pleasing.

Vendors accept responsibility for materials and goods displayed in their booth. Vendors are also responsible for providing and arranging all necessary labor for unpacking, erecting, dismantling and repacking displays. Event staff and volunteers are not available to help.

Vendors shall not store or display materials on benches, planters or other architectural surfaces.

Vendors shall provide a minimum of one trash receptacle at your booth. All packing cases, crates and debris of any kind must be removed from your booth prior to the time of opening. All additional trash, empty containers, packing materials must be removed when you leave.

All vehicles must be removed 1/2 hour before start of show.

NO EXCEPTIONS.

Set up information will be provided upon acceptance of application.

Breakdown of booths may not occur until close of show. Vendors must remove booth materials and contents within 1 hour of the close of show.
